

r. Bruce Magid is MTI's newest trustee. Before taking the reins at the College of Business in July, he served as the executive director of MSU Global, "an academic business unit that, via the Internet, connects working professionals and individuals seeking personal enrichment to the quality faculty, academic programs and other learning opportunities at Michigan State University" (MSU). Dr. Magid was also an adjunct faculty member of MSU's Department of Finance.

By fostering a collaborative relationship with MSU's major colleges to develop new online graduate-level programs, certificates, and continuing education activities, Dr. Magid was able to increase MSU Global enrollment from 800 to 10,000 and raise the number of programs from eight to 30 during his five-year tenure.

Dr. Magid also has experience in another area of great interest to MTI. He was the co-founder and co-executive director of the Global Community Security Institute, offering programs and certificates related to emergency management and homeland security. In that role, he developed and presented white papers to the Department of Homeland Security supporting MSU capabilities.

From 1977 to 1998, Dr. Magid was employed by the Bank of America. As a managing director and one of the top 200 senior executives (Key 200), he was responsible for major corporate strategy and development and corporate finance activities in Latin America, directing \$2.5 billion of investment banking activities.

Dr. Magid received his Ph.D. in International Economics, Business Law and Comparative Politics from the Fletcher School at Tufts University, after earning Master's degrees in International Economics and Law and Diplomacy, also from the Fletcher School. His distinguished academic career began at Georgetown University where he graduated Magna Cum Laude from the School of Foreign Service and was named as "Outstanding Graduate, Class of 1973."

Research Update

Ten new research projects are now underway, as outlined in the last issue of *World in Motion*. Eight are from our spring 2004 selection cycle; one is funded by FTA; and one is our BRT Handbook project for Caltrans. With the passage of the transportation reauthorization bill that funds MTI's basic grant, research is rapidly returning to the pace we had when I first arrived at MTI six years ago. That period also marked the beginning of a new funding grant after a period of cautious funding. We had research from three funding cycles within 15 months, and I dubbed the 30 projects in progress as the "pig in the python." We are perhaps looking at a piglet this time, but it will still be a significant increase in research activity.

Lining up are the two remaining projects selected in the spring of 2004, a new security/counter-terrorsim study focusing on major terrorist incidents since 9-11 and the changing nature of terrorists, and a major study of transportation funding options for the state of California. We will also be completing another round of selections from responses to the new RFP (currently planned for early September release) before the next edition of this newsletter. That would mean well over 20 research project in process. The timing of the next research RFP will depend on the results of the pending competition in spring 2006.

To prepare for all this activity, the MTI Board of Trustees has submitted potential study topics, and I have attended several meetings with various Caltrans groups discussing research needs and opportunities. I also scan for federal resource priorities and review other research in progress. Our research associates are encouraged to propose research directly requested in the RFP, but their proposals can also respond to Emphasis Areas outlined in MTI's strategic plan. Ultimately, the Research Associates Policy Oversight Committee (RAPOC) and the representatives of Caltrans and U.S. DOT will select proposals that score well, based on set criteria. These are:

- 1. Is the project of practical and timely value to transportation decision makers and professionals?
- 2. Does it address one or more of MTI's Emphasis Areas or respond to a specific RFP topic?
- 3. Does the project represent original research and identify how it expands upon previous research on the subject?
- 4. Does the proposed research team possess the expertise to conduct the research?
- 5. Does the proposed approach to the project demonstrate sound methodology?
- 6. Can the project be accomplished within the proposed budget and timeline?

Of course, every proposal must involve SJSU faculty and students since an important goal of the research program is to develop transportation expertise at SJSU. Descriptions of research in progress can be found on *TransWeb* at <u>http://transweb.sjsu.edu/proj.htm</u>.

Second National Transportation Security Summit: MTI's National Transportation Security Center (NTSC) will present this second national summit focused on rail systems security on September 29, following the APTA annual meeting in Dallas. Cosponsors include: AAR, AASHTO, Amtrak, APTA, U.S. DHS/TSA, U.S. DOT/FRA and FTA, NARP and others. Morning speakers include MTI's NTSC Director Brian Michael Jenkins on the changing character of the threat, former FTA Deputy Administrator and current TSA Deputy Administrator nominee Robert Jamison on evolving rail security systems, DHS Director of Border and Transportation Security Portfolio Jeanne Lin on mass transit security strategies, NTSC Emergency Response Specialist Dr. Frances Edwards on the NIMS compliance requirements, and former U.S. DOT Undersecretary now PB Consult's Chair Mort Downey on business continuity. The afternoon business continuity roundtable discussion, moderated by Mort Downey, will include as panelists NYCTA President Larry Reuter, NARP Chairman George Chilton, APTA Security Director Greg Hull, and recovery representatives of state and national DHS programs with new insights from the New Orleans experience.

MTI Executive Round Table with General Barry McCaffrey: On September 7th, MTI hosted local rail transit executives and security leaders for an afternoon discussion with international security expert General Barry McCaffrey, now chair of HNTB's federal programs. Executives from BART, CalTrain, Caltrans, FTA, Samtrans, SF Bay Area MTC, San Jose DOT, TSA, VTA, and private organizations shared an in-depth dialogue on the evolving terrorist threat and programs in development to improve security.
